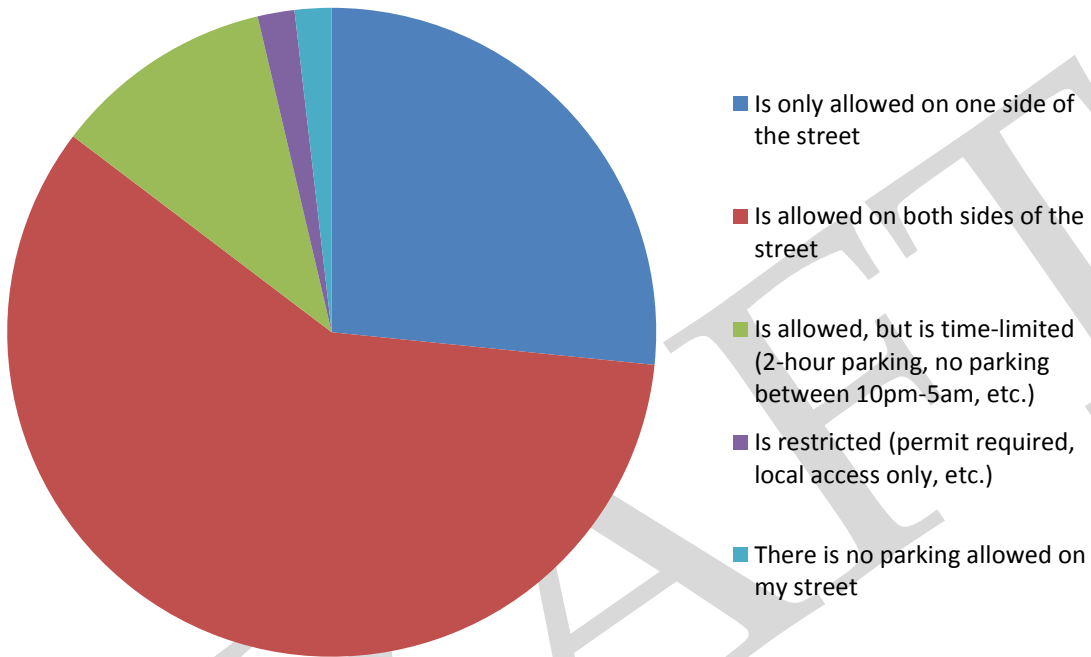

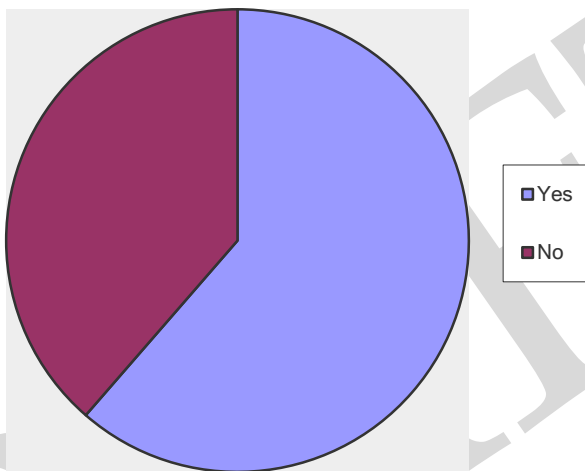

## Q7 Comments

- 3-Way intersection that is extremely dangerous. With the corridor, the area across the street has become parking for users. When people host parties, cars park all along the other side of the street illegally.
- Also a private parking lot across the street
- Apartment across the street accommodates one space only so residents w/2 vehicles park on the North side so it becomes a problem
- Cars are parked everywhere - from 6th up to in front of our homes. Many park with half their wheels too far into the road causing you to stop or swerve into the oncoming lane to get safely by.
- Difficult to navigate when cars are parked on both sides, there isn't always room to move over to the side when a car is coming toward you
- I'd say that given the addition of bike lanes, it is minimal and perhaps dangerous to bikers
- It could probably handle intermittent parking on both sides...
- It is a small street with a lot of homes. Trying to navigate out of the driveway and be able to see if there is traffic is tough The waste management vehicle often struggles to come down sometimes. Even tougher trying to turn onto 5th.You have to nose out way too far before you can see past the parked vehicles that block your view.
- it is full of cars all day and down 2 1 lane all day
- It is used by emergency vehicles & fire trucks because parallel streets have roundabouts that they cannot navigate. Parking on both sides of 10th Ave. S. slows the down. Two cars cannot pass each other when cars are parked on both sides of the street. Apartment & condo owners tend to park on the street at night & on weekends.
- Just wide enough. If cars are going to pass with Parkersburg in both sides, usually one waits until the other passes.
- Lots of bus riders park on street and block mailboxes and garbage, recycling, yard waste pickup. Some even block bus stop. Drivers block driveway almost every weekday with bus drop off or pick up

## Q7 Comments (cont)

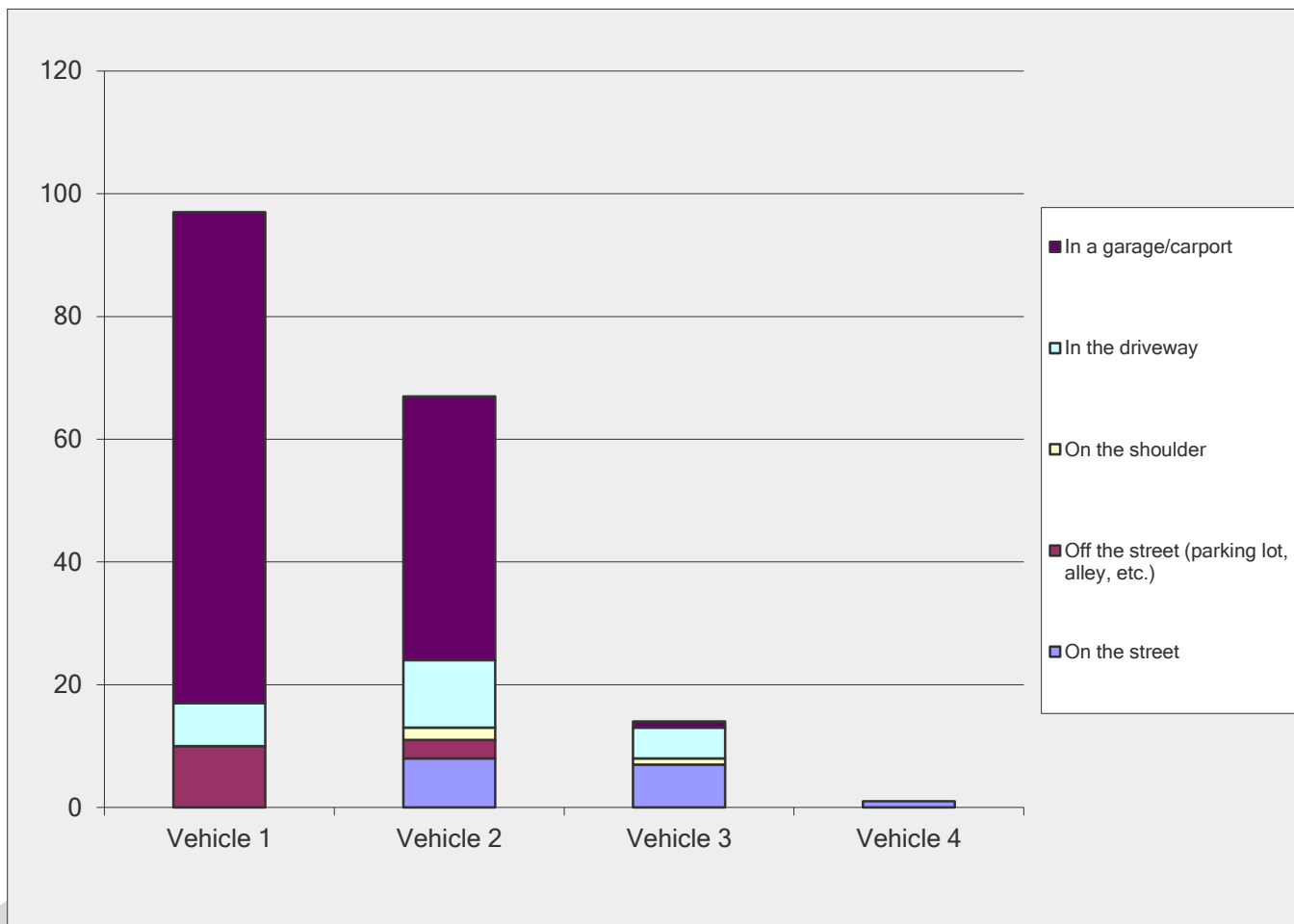
- Road feels narrower due to speed bumps on 10th Ave S., so heavy street parking makes road feel cramped.
- Sidewalks both sides part, one side the rest. Condominiums with limited parking are one lot away and accessible through a walkway, residents and visitors park on our street and walk through to the condominiums. With parking only on one side this limits parking for tradesmen and guests for our street.
- Single family resident on the corner of 2nd St S. and 2nd Ave has painted a red zone on the curb in front of his home to prevent public parking. Please address.
- Some of the no parking signs were remove with the new side walk. Now they park on both sides during events in kirkland. Hard to get through to are home.
- Speeding is a big issue on 2nd Ave. south. I've called the City and they don't think there is an issue. cited some traffic study from 15 years ago. A lot has been built since then. There was a bad accident there 2 weeks ago.
- Street is barely wide enough.Cars sometimes park on no-parking side of the street (south side).
- Street is very narrow in parts and sometimes tough to navigate.
- The intersection of my 2 cross streets are blind spots as is the entrance/exit to the 2 garages into the building (Portsmith) on 2nd Ave. Second St also curves around a corner to become 1st Ave SO. This is also a relative blind corner. Both streets (2nd Ave SO and 1st Ave So) barely have room for two cars. There are also FedEx, USPS, UPS, large moving trucks, garbage trucks that are parked on 2nd St. SO. All day long. The street is also congested with traffic that is being diverted all summer long for Kirkland events, where Lake Wa Blvd is detoured.
- The streets are public property where anyone can park, bike and walk.
- There are parts of the street where people part on both sides, it makes it narrow to get through.
- Two cars cannot drive past each other when cars are parked on both sides of 2nd Street South.
- Very dangerous curve-- blind to coming traffic
- Very little public parking available on the street as a whole, but wide enough for what is there currently. Also - question 5 above should allow you to click more than one response, but you're limited to one on the survey.

## Q7 Comments (cont)

- Very short little street; turns into a public path after about a block
- We are woefully lacking adequate sidewalks in this area.
- When cars park on both sides of the street, it makes it difficult to pass - must stop to allow for 1 way traffic passing at a time
- when cars park on both sides only one car can come through at a time
- We live near Houghton Park. It is impossible for our guests to find parking in the summer because park patrons clog up the streets north, south and west. I do not know what the answer is but it's very hard on the residents.
- It's dangerous to cross (no crosswalk) and parking is encroaching onto the street and too close to the intersection. Kirkland Ave is also being used as an "race-around" short cut and needs speed bumps.

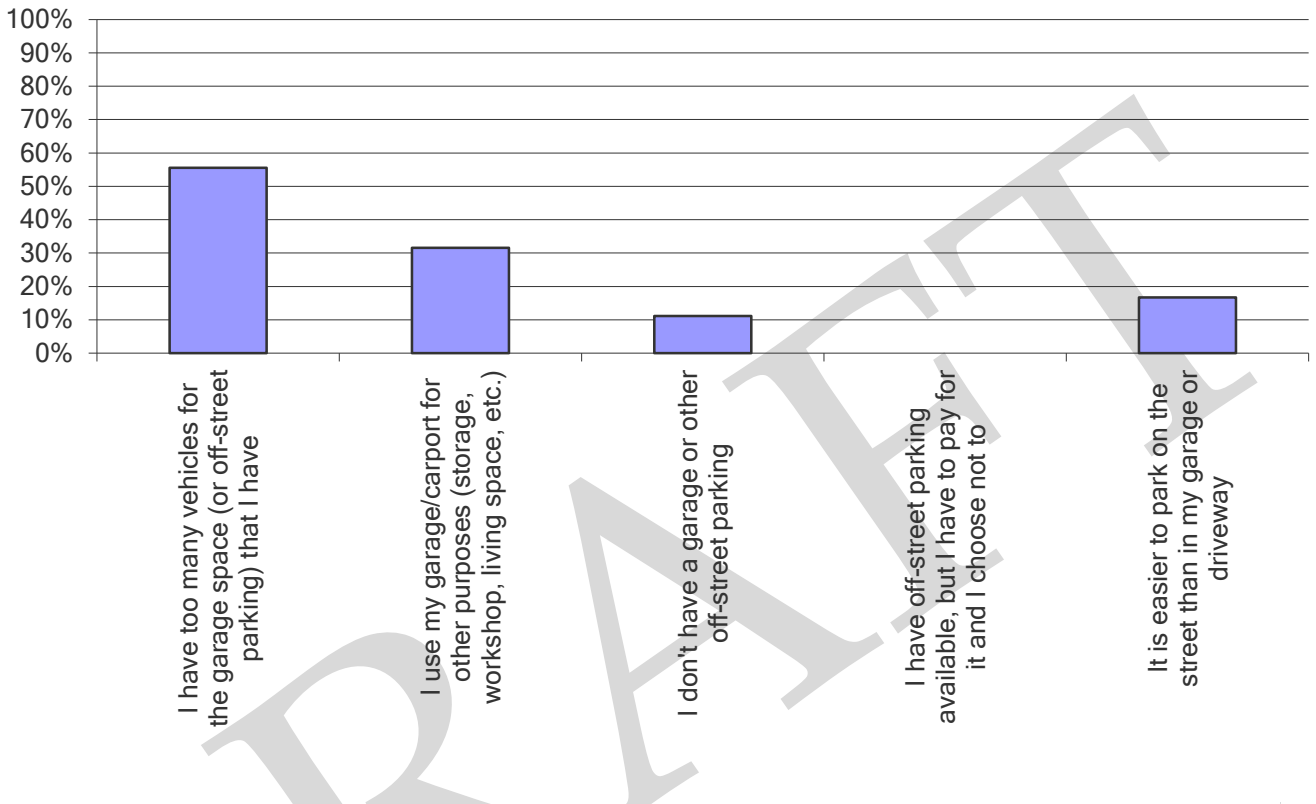

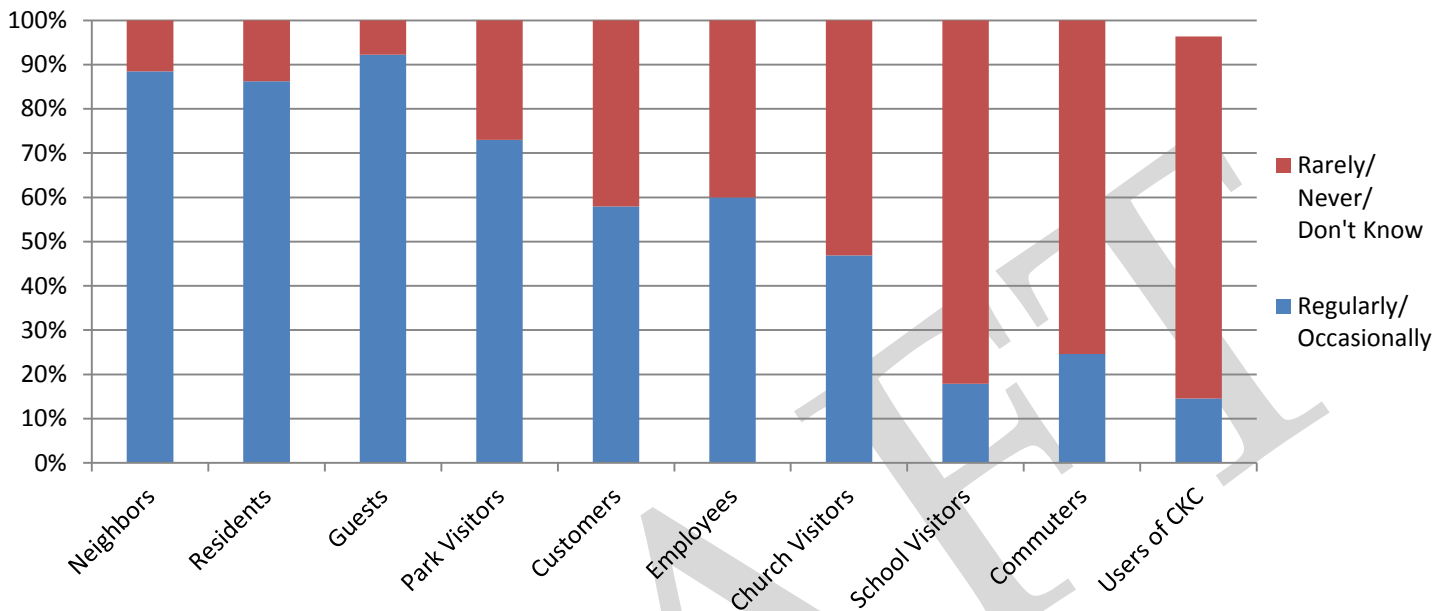

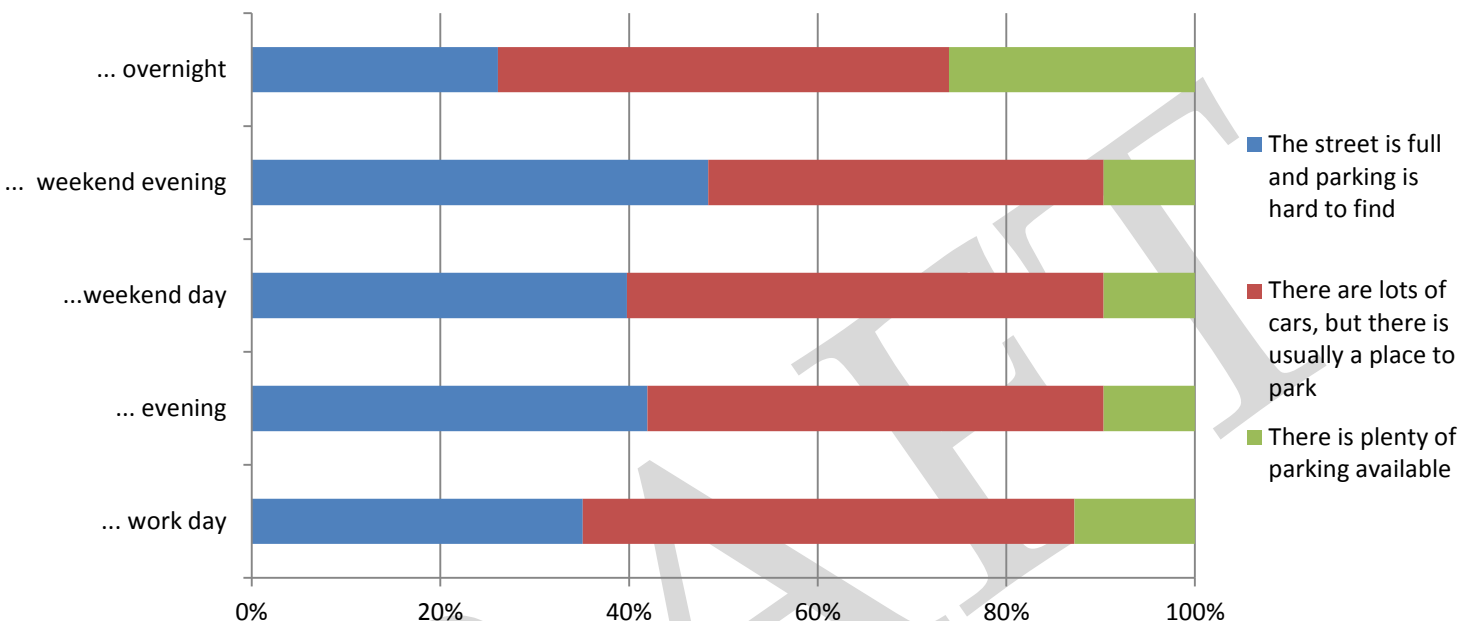

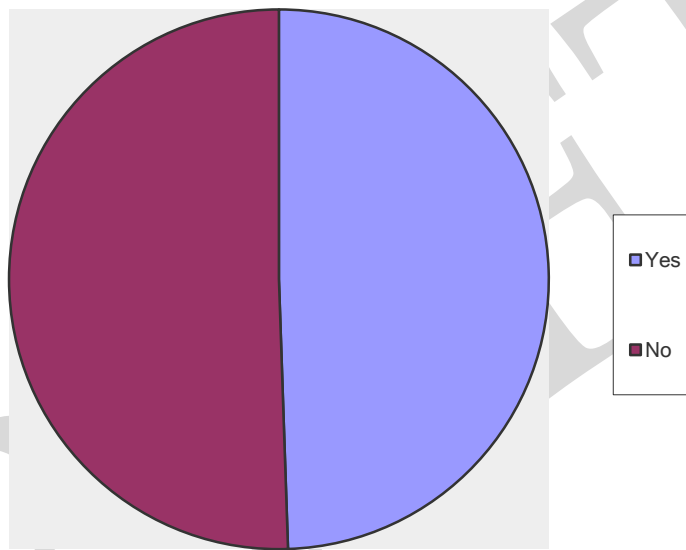
- Also construction workers involved in the many projects.

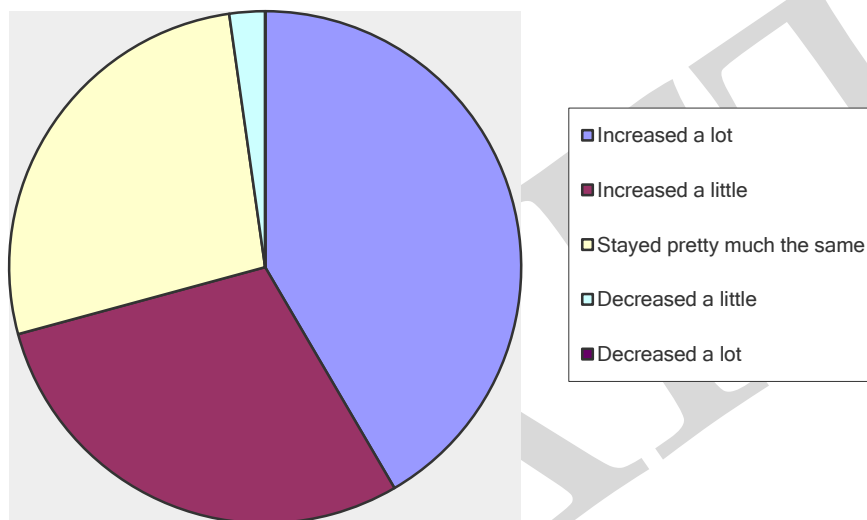
## Q12 Comments

- Many retail customers don't know about our street

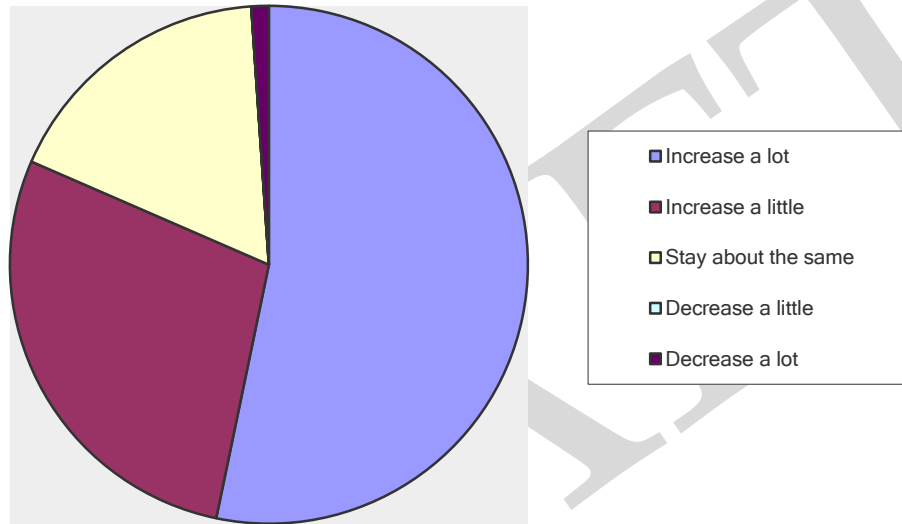
## Q13 Comments (cont)

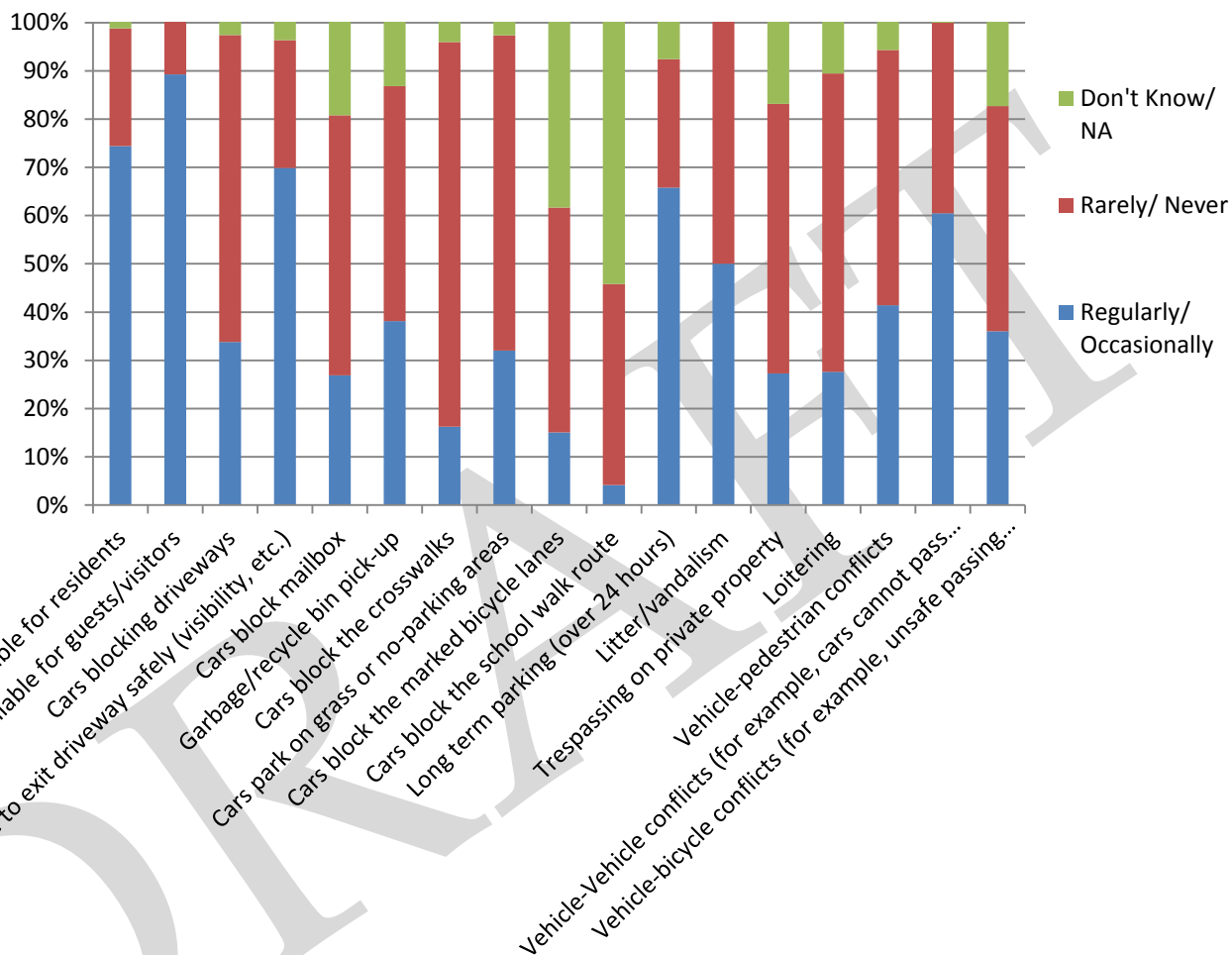
## Q14 Comments (cont)

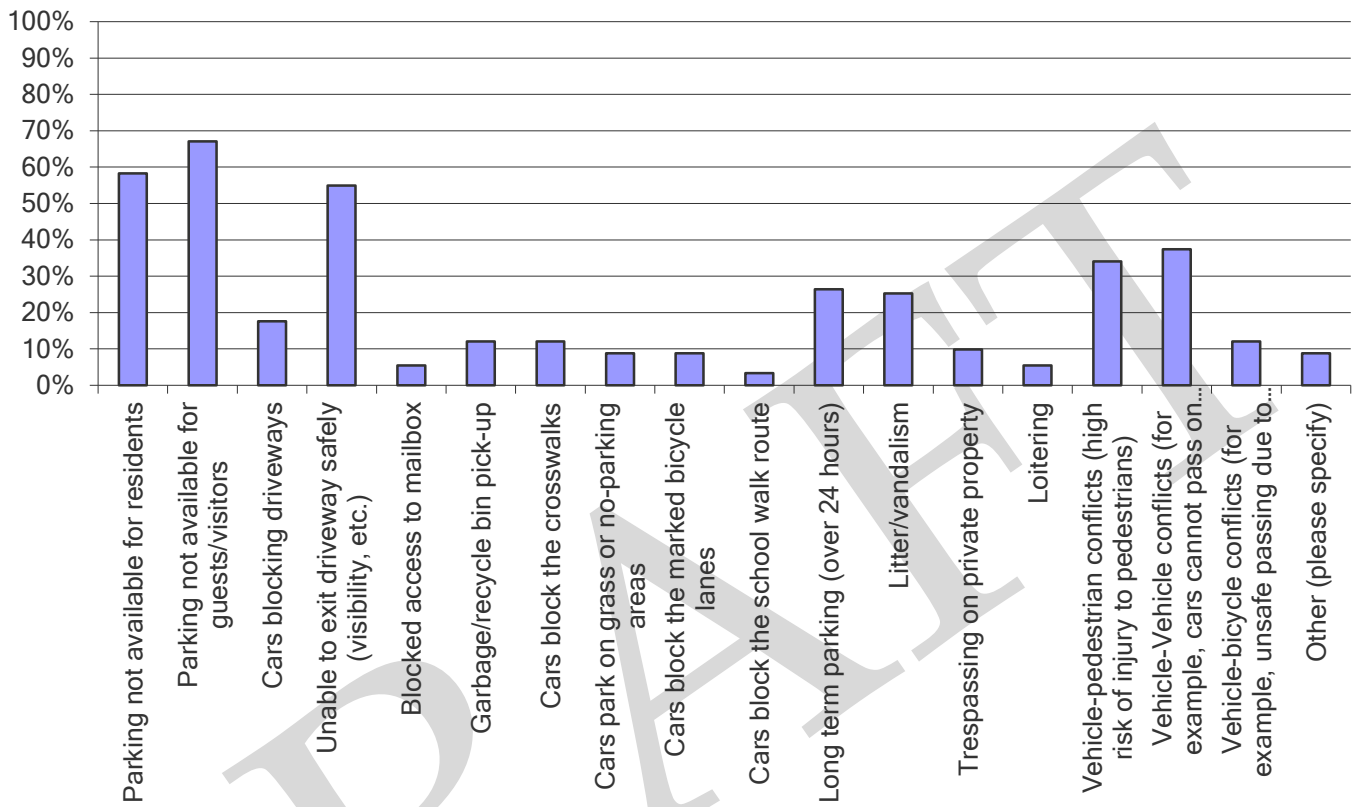

- These response reflect conditions on 2nd St S. Cars exiting the two garages on 2nd Ave S often cannot see traffic around cars parked on the street. Additionally, while there is no parking on the south side of the street, during special City events or hot summer days, cars are parked there turning the road into a one-way passage.
- Traffic is dreadful from 4 - 5:30 every weekday. It's challenging to get out of our driveway
- When the bars on Central Way close between midnight and 1:30am, there is sometimes noisy conversation among people walking to their parked cars. I've learned to ignore it because they usually keep walking or get in their cars and go home. Once in a while loud voices will be heard on the sidewalk outside my bedroom window. I've developed a strategy to get them to move on: I shine a flashlight on them; almost always they stop their chatter and get into their cars and drive away.
- Skateboards!! Bicyclists and walkers not paying attention to ingress/egress driveways on Lk WA Blvd. walkers and joggers looking at cell phones or earplugs.
- Being there isn't a crosswalk at the intersection and the fact that cars are using Kirkland Ave as a race-way shortcut, walking and crossing the street is very dangerous even crossing 6th St. The intersection needs a stop sign and Kirkland Ave needs speed bumps.

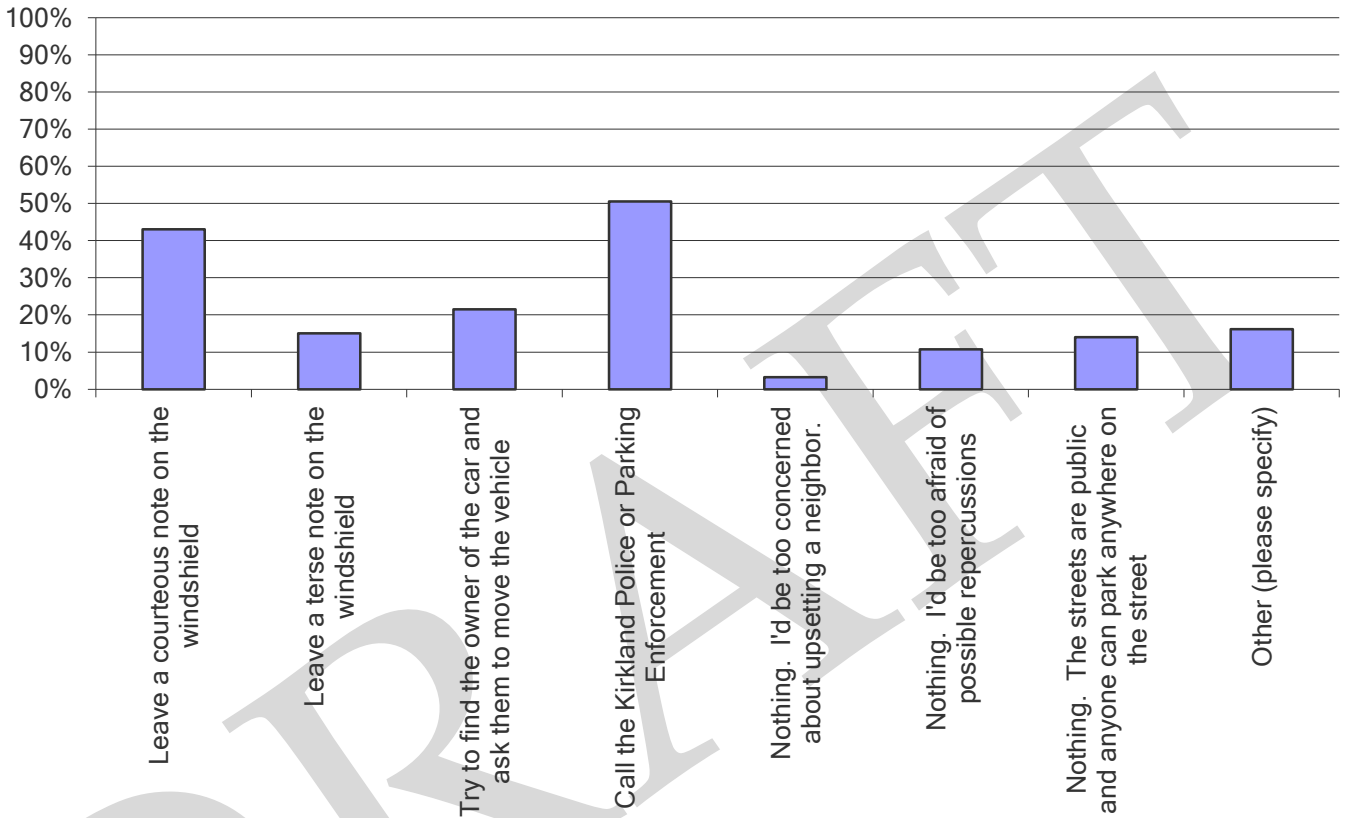

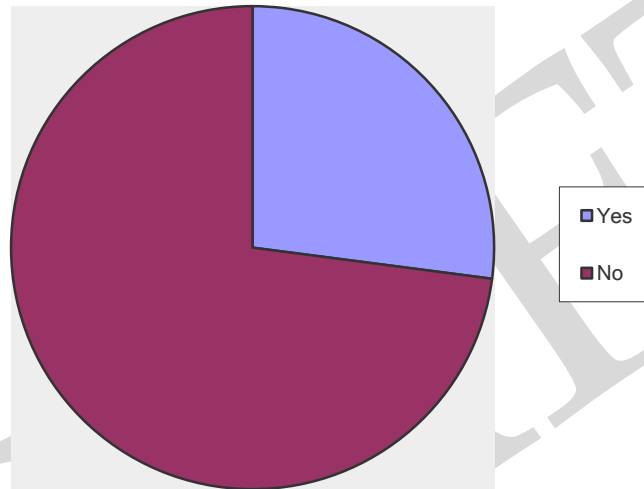

- Guy across the street between 2nd street south and 2nd Ave puts orange cones in front of his house in order to save spots for his wife or son when they have a driveway that could accommodate 2 family cars. They also put there boat and trailer on public street parking. For 8 years. I have complained to parking enforcement and was told to call when I see this action.

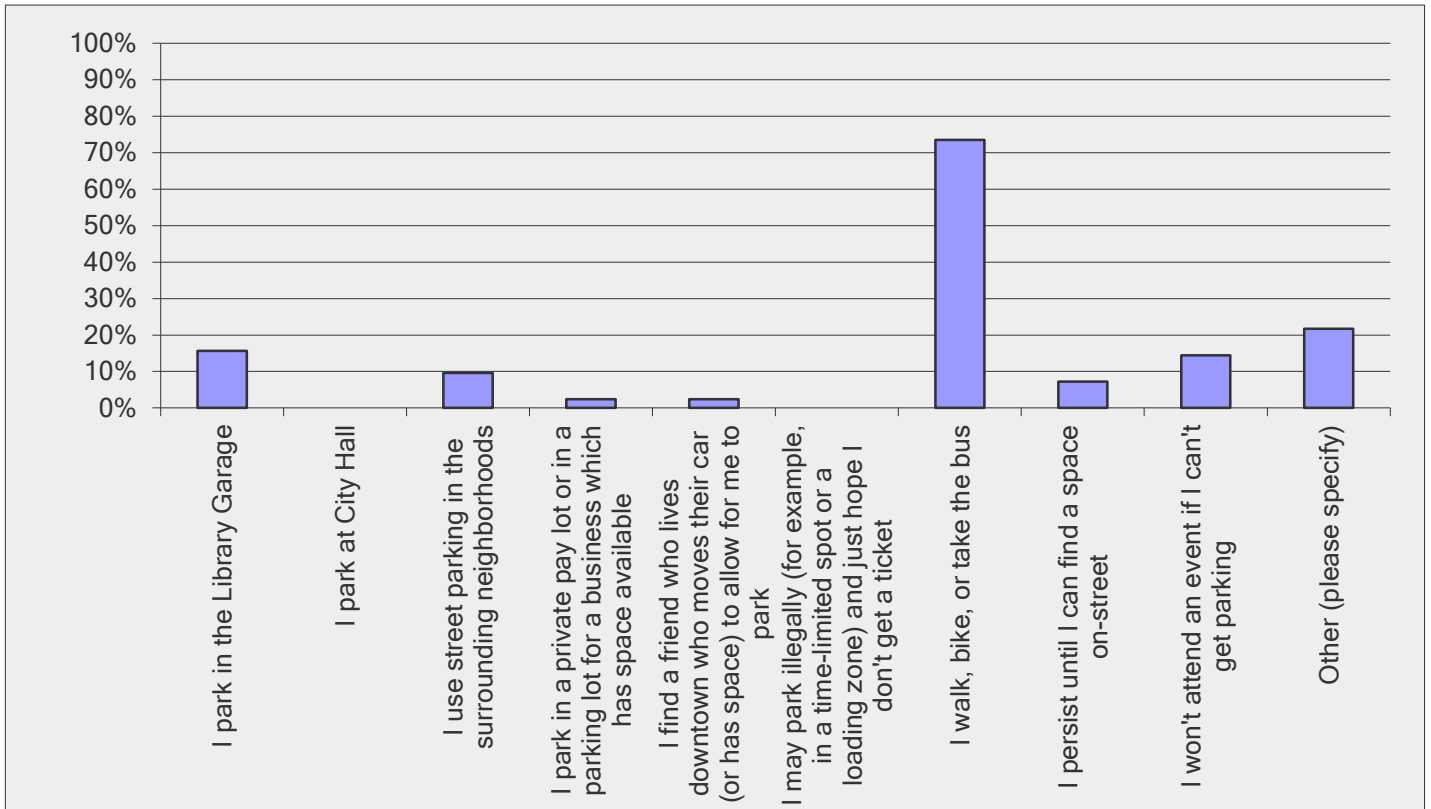

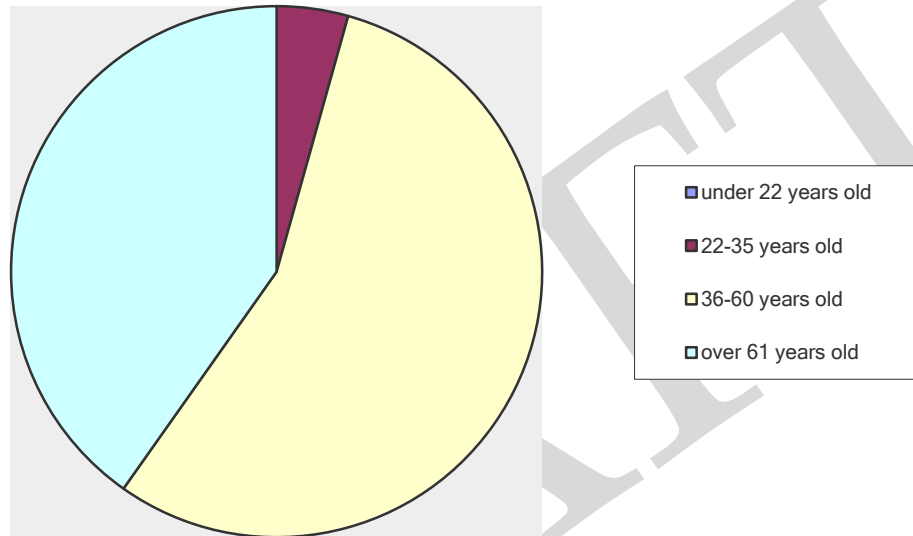
